Supervisor Bonding – Interim Supervisor Davis will acquire the necessary bonding in the amount of Twenty Four Million Dollars.

Antioch Township 2018 Levy – The board discussed the Township Levy. Supervisor Smouse had already reported that the Township would freeze the Levy, the board agreed. Motion to freeze the 2018 Levy was made by Trustee Grant, second by Trustee Shepard. Motion carried 4 Yes: 0 No: The Levy will be approved at the December meeting.

Executive Session – Trustee Turner stated choosing a new supervisor was unchartered territory. He would like to discuss the proper procedures for a board decision. With this conversation all Trustees will have the same understanding of state law. Motion to enter executive session at 7:12PM was made by Trustee Turner, second by Trustee Shepard. Motion carried with a roll call vote 3 Yes: Turner, Shepard, Davis 1 No: Grant

Motion to end executive session and return to Special meeting was made by Trustee Shepard at 7:32PM, second by Trustee Grant. Motion carried with a voice vote.

There was no further business to come before the board, Peter Grant made a motion to adjourn, second by Kris Shepard, all in favor and the meeting adjourned at 7:33PM.
