The Road District bills were presented for payment in the amount of \$44,383.89. Motion for payment of the road district bills was made by Trustee Grant, second by Trustee Davis. Motion carried 5 Yes: 0 No

Township Officials Report – Supervisor –The Township has been certified for the LIHEAP energy assistance program with CAP and the SHIP program.

Assessor – The Assessor's office is accepting flood exemptions. Monday October 16, 2017 is the last day for board of review changes.

Highway – Peter Baker has finished the blacktop, shoulder gravel has also been finished. Highway Commissioner met with Jim Keim from the village. The Village will be maintaining Grimm Road moving forward. October 19, 2017 Storm Water Management Commission is hosting a Homeowners Floodproofing Expo and Workshop. The event will be held at the Libertyville Sports Complex from 3:00 - 8:00 p.m.

Clerk – Contracts have been signed with the county for the 2018 elections. Antioch Township will be an early voting site as well as an Election Day site.


